- 2. Application fee. If by check or money order payable to the: City of Chicago, Department of Revenue.
- 3. All applicants must be 21 years of age and must provide an original signed letter (on company Stationery) from their current or former employer's "Supervising Electrician".
- 4. The letter must verify the dates of employment and establish a minimum of two (2) years' cumulative experience in the installation, maintenance or alteration of building wiring systems relating to the applicant's category of the Supervising Electrician's license examination.
- 5. The letter must include a description of the applicant's duties and responsibilities and be signed by a Supervising Electrician with an active City license.
- 6. The letter must include the Electrical Contractor's license number.

OR

- 7. If the applicant's work experience is limited to a State, County, or local jurisdiction, which does NOT require licensing and/or registration of electrical contractors, or electrical wiring permits, the applicant must provide a letter of verification from that jurisdiction along with a detailed, chronological history of the applicant's work experience.
- 8. The letter must be accompanied by a photocopy of the employer's Electrical Contractor license photo ID card.
